

1. GENERAL PROVISIONS

NGA «MFU» is a voluntary, professional, independent, self-governing public union in the field of mediation and conflict resolution, which is created on the basis of common interests to achieve the goals and objectives set out in this Statute.

3. PURPOSE, GOALS AND DIRECTIONS OF ACTIVITY

The basic tasks of the Mediation Federation of Ukraine will include:

creating and maintaining an effective mediation system as an institute of legal system of Ukraine, competing with state courts;

introduction and development of the culture of mediation in Ukraine;

ensuring the accessibility of mediation services to all individuals, legal entities or groups of persons.

Mediation can be used in any conflicts (disputes) that arise in civil, family, labor, economic, administrative legal relations, as well as criminal proceedings during the conclusion of reconciliation agreements and in other areas of public relations.

3.2. The basic functions of the Mediation Federation of Ukraine include:

3.2.1 Involvement of scientists and specialists in solving current scientific and practical problems in the field of mediation in the interests of society as a whole.

3.2.2. Facilitating the consolidation of the forces of the members of the Federation and creating conditions for the fullest possible realization of the creative potential of professional mediators of Ukraine.

3.2.3. Facilitating the dissemination and promotion of mediation in Ukraine.

3.2.4. Facilitating the process of providing information about mediation to interested consumers, as well as the initiative implementation of the achievements of mediation theory in practice.

3.2.5. Facilitating the improvement of the system of training and retraining of professional mediators.

3.2.6. Facilitating the implementation of projects, programs and activities aimed at improving the methods and practical mediation techniques, procedures for mediators.

3.2.7. Facilitating of information support for mediators, exchange of experience in research and practical activities, development of progressive forms of work.

3.2.8. Facilitating activities to improve the professional culture and skills of mediators.

3.2.9. Implementation of educational activities on spreading the culture of alternative (out-of-court) conflict resolution.

3.2.10. Coordination of the activities of mediators - members of the Federation in order to rationally distribute the efforts of specialists in the most important areas of science and practice.

3.2.11. Providing members of the Federation with informational, theoretical and methodological assistance in improving the level of professional training.

3.2.12. Inclusion of the Mediation Federation of Ukraine in the system of the international mediation community.

3.3. To implement its statutory goals and objectives, the Federation, in accordance with current legislation of Ukraine, carries out the following activities:

- 3.3.1 Realization of permanent representation of mediation interests as a separate sphere of professional activity before all stakeholders;
- 3.3.2. Promoting the development of the mediator profession;
- 3.3.3. Monitoring and taking measures to improve the quality of professional training and professional activities of mediators;
- 3.3.4. Development and enforcement of qualification requirements for mediators and the structure of professional profiles of mediators;
- 3.3.5. Adoption of regulatory acts in the field of mediation;

3.4. Maintaining the register of mediators of the Federation of Mediation of Ukraine:

- 3.4.1. Creation and support of the current functioning of the Register of Mediators of the Federation of Mediation of Ukraine as a tool to ensure the availability of mediation to all segments of the population and its proper quality;
- 3.4.2. Maintaining the Register of Mediators;
- 3.4.3. Ensuring the entry in the Register of information about mediators and the results of their professional activities in the field of mediation;
- 3.4.5. Development of mediation standards and ethical rules of conduct for mediators;
- 3.4.6. Adoption of rules for appealing the activities of mediators and disciplinary rules;
- 3.4.7. Creating opportunities for continuous access to the Register of Mediators.

3.5. Creation and maintenance of continuous functioning of the website of the Federation of Mediation of Ukraine;

3.6. Holding the annual National Conference of Mediators.

3.7. Implementation of scientific, educational, publishing, consulting activities.

3.7.1. Organization and holding of conferences and meetings, symposia, readings, discussions on the most pressing issues of modern mediation.

3.7.2. Promotes the creation of research and scientific-practical centers, training courses.

3.7.3. In the interests of national and world mediation, international contacts, participation in foreign national and international mediation congresses, conferences, symposia, participation in international projects and programs, organization and exchange of trainees and specialists.

5.2. The General Meeting of the Federation is a body that has the right to make decisions on any issues of its activities, including those that fall within the competence of the Federation Council.
